As additional consideration for the final payment, the undersigned agrees to the fullest extent of the law to, indemnify and hold harmless Regal Renovations from and against all costs, losses, damages, claims, causes of action, judgments and expenses, including attorney's fees, arising out of or in connection performance of the work under the Project and which may be asserted by the undersigned or any of its suppliers, sub-subcontractors of any tier or any of their representatives, officers, agents or employees except for those claims listed .

The foregoing shall not relieve the undersigned of its obligations under any agreement it may have with Regal Renovations, which, by their nature, survive completion of the work, including without limitation, warranties, guarantees, and indemnities.
